Tiers of Instruction

We have diligently prepared three different tiers of instruction for the 2020-2021 school year. Our goal is to ensure that we are able to meet the needs of our students in each tier while being prepared to transition between the tiers as the health and safety circumstance of our community changes.

- <u>Virtual</u>: All learning will be done at home through classes delivered virtually using both synchronous (live) and asynchronous (lessons or assignments that can be viewed/completed at any time because they are not being delivered live) lessons. Parents have two options for virtual instruction: Hallsto-Home (instruction delivered and managed by SASD teachers) or Shippensburg Area Virtual Education (instruction delivered and managed by a third-party vendor-CAOLA).
- <u>Hybrid</u>: Students will alternate between learning face-to-face in our school district classrooms and learning at home. This option will be used in our scaffolded reopening plan to ensure social distancing guideline and cleaning protocols can be followed.
- <u>Face-to-Face</u>: Our students are able to attend school each day in an SASD classroom.

Remote Learning Tips for Families

The Role Parents/Family Members Play in Remote Learning

- Students should see their parents/family members as their greatest coaches, knowing a coach won't be misleading or overly positive, but constructive and goal-oriented.
- With parents/family members as coaches that reinforce the value of working through hardships, students at any age can be empowered to persevere through this critical time.
- Parents/Family Members should reinforce learning by encouraging students to be responsible and consistent in their work habits.

Parents/Family Members Set the Standard

- Parents/family members control the home learning environment.
- Parents/family members can support learning my setting the pace, creating a physical space intended for learning, and continuing to encourage students in the absence of daily face-to-face teacher interaction.
- By designating an area of the home for learning, parents can also keep an
 eye on progress.
- Noting behaviors, opportunities and barriers, allow parents/family members to adapt or adjust as necessary to create the ideal path for their child or children.

Power of Parents/Family Members

- By positioning education as a priority, parents/family members can reinforce the importance of doing well in school, regardless of their own backgrounds.
- Setting an increased value for education and learning can come through in how a parent/family member dictates online learning time, prioritizes needs, and provides personal attention.
- Parents/family members have a direct impact on the education students receive, especially in a remote learning setting.

HEALTH & SAFETY

Face Covering Protocol

On July 1, 2020, the PA Secretary of Health issued an Order requiring all individuals to wear a face covering when they leave their homes. The order outlines situations when a face covering must be worn. The Secretary issued this Order to continue to protect all the citizens of the Commonwealth from the spread of COVID-19, mindful of the need to slow the increasing number of cases as the Commonwealth reopens and in order to avoid the resurgence that is overwhelming the health care systems and public health systems in other states that have been less successful in reopening than the Commonwealth.

The Universal Face Coverings Order applies to individuals aged two and older whenever outside the home, including public K-12 schools. This Order became effective July 1, 2020 and will remain in effect until the PA Secretary of Health determines the public health risk is sufficiently reduced so that face coverings are no longer necessary as a widely used public health tool.

As per the PA Secretary of Health's Order, all students, staff, and visitors of the Shippensburg Area School District must wear face coverings while using transportation, on school grounds, and in school buildings. Face covering, defined as a covering of the nose and mouth secured to the head with ties, straps, loops over the ears or wrapped around the lower face, can be made of a variety of synthetic or natural fibers, including cotton, silk, or linen, and for the purposes of the Order, can include a plastic face shield that covers the nose and mouth. Any student, staff member, or visitor who does not have a face covering may request a face covering from the building administrator. Any student, staff member, or visitor who cannot wear a face covering due to a medical condition should contact the building administrator to address this concern. Face shields may also be worn.

Masks will be available in the main office of each District building for students and staff who forget or misplace their face coverings. Students and staff are expected to bring their own face covering to school with them on a daily basis.

At Home

Parents/guardians must complete the COVID-19 Daily Self Checklist for each child living in the household before sending their child to school each day. The daily checklist requires you to take and record your child's temperature. In addition to the daily checklist that you maintain, students will also have their temperatures taken prior to entering their school facility. The questions must be answered before reporting to school and you must retain this log indefinitely. Your school may ask to review your checklist should your child test positive for COVID-19 to assist with contact tracing. If you answer yes to any of the screening questions, or have 3 symptoms, or you have a fever of 100.4 F or higher, DO NOT REPORT TO SCHOOL. Call your school health room office. See Appendix for Student Home Health Screen form.

At School

- Office Staff at each school district building entrance will ask all who wish to enter to answer questions regarding common symptoms and possible exposure to the COVID-19 virus. Office Staff will determine if visitors may enter the office area.
- Visitors are limited to SASD employees and contracted service providers who comply with face coverings, hand washing and social distancing protocols.
- CDC and PA Department of Health posters and posted in high traffic areas of the buildings.
- Posters are present in each room as a reminder of healthy practices.
- All students, staff, and visitors must wear a face covering except when:
 - eating or drinking,
 - o participating in an activity (face covering breaks, outdoor fresh air breaks, physical education class, recess) while practicing social distancing guidelines.
- Large group gatherings are restricted.
- Students, staff, and visitors experiencing COVID-19 related symptoms will report to the nurse's office immediately.
- A hand washing schedule will be employed for all students and staff
- Students, staff, and visitors will wear face coverings while in the building when maintaining social distancing is not possible.
- Vigilant cleaning of high touch surfaces (desks, keyboards, door handles, etc...) will be enforced.
- Soap, hand sanitizer, and disinfecting wipes will be provided in the classroom and throughout the school building.
- Students, staff, and visitors will not share personal belongings.
- Use of floor markings to help student and staff maintain social distancing.
- Modify schedules to provide classroom coverage and student supervision.

- One-way hallways where possible.
- Rotating recess times (with low or no contact activities) at the elementary schools.
- Physical Education will be conducted virtually or at the school utilizing noncontact activities.

Transportation

- Students will be required to wear a face covering when using District provided transportation.
- Drivers of district contracted transportation services will be required to wear a mask when students are on vehicles.
- The number of students riding on District provided transportation will be limited.
- Students will sit up to two to a seat, sitting by the window and by the aisle.
- Vehicles will be cleaned and sanitized after each route.
- Windows and roof hatches will be opened, when possible, to allow for additional ventilation.
- Vehicles will be loaded from back to front and unloaded from front to back to minimize student contact.
- Students will be dismissed to the buses and as walkers in a staggered manner.

Cafeteria Services

- Elementary Buildings (Grades K-5)
 - Breakfast will be grab-n-go style (prepacked disposable bags) with social distancing as the students enter the building.
 - Breakfast bags will be available on mobile carts at specific locations in the building.
 - All students will eat breakfast in the classroom.
 - Teachers will be provided trash bags for breakfast trash. Trash will be collected at the end of the breakfast period.
 - o Teachers will send the breakfast and lunch count to the kitchen.
 - o Kitchen staff will deliver the lunches to the classrooms at the designated lunch times.
 - Students will eat their lunch in the classroom.
 - Teachers will be provided trash bags for lunch trash. Trash will be collected at the end of the lunch period.
 - SASD will be offering at-home meals for the days that students are not physically in school. Parents may preorder by visiting the SASD website and clicking the Food Service tab.
- Secondary Buildings (Grades 6-12)
 - o The lunch will be a bagged lunch served in the cafeteria.
 - Students will eat in the cafeteria.
 - o The typical lunch options will not be available.

Classroom

- Instructional time will be prioritized to accommodate student needs.
- Elementary Related Arts instruction (Art, Music, Health, Library/Media Center activities, Guidance class) will be held in the homeroom classroom.
- K-3 students will participate in Daily Morning and Closing Circles designed to build classroom community and support social-emotional wellness.
- To help ensure social distancing, classroom desks and tables will be placed 6 feet apart. All students will sit at desks facing the same direction.
- The teacher will have a designated space in the classroom that will be maintained as a student-free zone.
- Health and Safety activities will be incorporated into the daily routine and curriculum.
- Sharing of instructional materials will be limited.
 - Shared materials will be disinfected between uses.
 - o Students will have their own assigned technology device.
 - Physical Education activities will be virtual or will be individualized rather than pairs or teams.
- Students and staff will be expected to use "respiratory etiquette" by coughing or sneezing into a tissue or elbow area of the arm. If using a tissue, the person will be expected to wash their hands or use hand sanitizer.
- Teacher will provide specific instructions regarding assignments students will complete on the days they are learning at home. These assignments will be directly connected to the direct instruction they receive from their teachers while in the school building.
- Classrooms will be configured to ensure compliance with 6-foot social distancing guidelines. Unnecessary furniture will be removed and dedicated space for teacher instruction will be provided.
- Class size will be limited to support social distancing guidelines

Virtual Learning

- All parents/guardians may request a technology device for their child to use for virtual learning.
- Parents/guardians are responsible for the condition of the technology device while it is in their child's possession.
- All activity on the device is monitored by SASD through the use of GoGuardian software. If your child is attempting to visit inappropriate websites or conducting "troubling" web searches, you will be contact by a District Administrator.

- Teacher will provide direct instruction through synchronous or live face-toface interaction. Synchronous instruction will be recorded during the Zoom instructional time and posted to the learning platform for viewing at any time by the parent/guardian or student.
- Teachers will provide asynchronous activities posted in the learning platform.
- Grades K-5 will use Google Classroom, while Grades 6-12 will use Google Classroom with Schoology integration.

Internet

If you do not have internet at your home, you may request an internet hot spot from the school district. If you are currently receiving free or reduced meals at school, you may request information about the receiving internet at a discounted rate. Please contact your school Principal for more information.

DATA PRIVACY & SECURITY DURING REMOTE LEARNING:

Shippensburg Area School District can only ensure the safety of your child's digital footprint and identity if he/she is using the district owned technology and district-approved applications. The use of any other websites/applications or social media platforms is at the discretion of the parent. We strongly encourage you to read the privacy policies of any non-district approved applications to ensure that your child's identity is properly protected. If you are unsure whether a resource is approved by the district, please contact your school. As a community, we must all remain especially vigilant about cyber-security in the weeks and months ahead.

School Nurses

Each school building will have a licensed nurse present throughout the school day. School nurses follow Department of Health and CDC Guidelines related to COVID-19 and will assist administrators and staff in understanding and implementing those guidelines. School nurses have been provided with COVID-19 specific protocol for assessing and managing student and staff health needs including parent communication, managing students who exhibit symptoms during the school day, and supporting staff member who exhibit symptoms during the work day. Our nurses will also support he District's safety plan by upholding social distancing, face covering protocol, and effective hand washing procedures. Nurses will continue to provide daily medication as needed and attend to other illnesses and injuries that might occur during the school day. Immunization requirements remain in effect as per Shippensburg Area School District and PA Department of Health policies. School nurses continue to collaborate with school counselors and administrators to provide support for students with special learning and medical needs.

Protocol for a confirmed case of COVID-19 in our schools

If the District Administrators or Health Services Staff are made aware of a confirmed case* of COVID-19, they will follow the CDC Guidelines, Cumberland and Franklin County Department of Public Safety's guidance, and physician orders regarding safe COVID-19 mitigation and management protocols.

Per these guidelines, the District will:

- Direct the student or staff member to remain at home for a minimum of 14 days from the onset of symptoms and follow the orders of their health care provider.
- Identify any individuals who had close contact** with someone with a confirmed case of COVID-19 within 48 hours of symptom onset and notify them to quarantine for 14 days.
- Keep the identity of the individual with a confirmed case confidential pursuant to the Americans with Disabilities Act when notifying others that they may have been exposed to COVID-19 in our schools due to close contact.
- Follow cleaning and disinfecting protocols in accordance with CDC guidelines and the SASD Health & Safety Plan.

^{*}Confirmed Case is defined as a person has had a COVID-19 test and the results have come back positive. The person is under physician treatment.

** Per CDC, close contact is defined as "any individual who was within 6 feet of an infected person for at least 15 minutes starting from 2 days before illness onset (or, for asymptomatic patients, 2 days prior to positive specimen collection) until the time the patient is isolated."

***Parents must provide documentation from a medical professional of a confirmed case.

Return to School

Each student situation will be evaluated on an individual basis by the School Health Staff and Administrator by using the following general guidelines.

*Students must be without a fever for 24 hours without using a fever reducing medication (Tylenol, Motrin, and Acetaminophen)

However, this school year, elementary special subjects (Health/PE, Art, Music, Library/Media Center activities, Guidance) will be graded using an O, S or N.

Bullying and Harassment

COVID-19 is not at all connected to race, ethnicity, or nationality. Acknowledgement of Virtual Group Instruction Privacy Concern

The Family Educational Rights and Privacy Act (FERPA) and the Health Insurance Portability and Accountability Act (HIPAA) are federal laws that protect confidentiality of a student's education and health records. Shippensburg Area School District complies with federal regulations outlined in both FERPA and HIPAA to ensure student confidentiality. In response to the COVID-19 nationwide public health emergency, the United States Department of Health and Human Services has provided guidance that the Office of Civil Rights recognizes the challenges of school districts to meet the needs of our students remotely; therefore, they have made accommodations with regulatory requirements related to HIPAA rules. The department supports the use of any audio and video conferencing product that allows only the intended parties to participate in communications in order to provide services to students virtually during the public health emergency.

In order to provide students with a continuity of education during this unprecedented time, Shippensburg Area School District, would like to engage your student in group virtual instruction using nonpublic audio and video conferencing. The district will be utilizing Google Applications and/or Zoom to support remote learning. This letter serves to notify families that Shippensburg Area School District cannot ensure student privacy when utilizing group virtual instruction. During a virtual group instruction, student's names and faces may appear on a screen. Further, the virtual group instruction format could provide opportunities for individuals in other student's households to observe the learning session. As a reminder, the district will not share health and educational information with third parties without written parental consent. This letter serves to notify Shippensburg Area School District families of the district's good faith effort to provide instructional opportunities for socialization during this unique time using a product that complies with the current Department of Health and Human Services rules.

The district plans to move forward with providing group virtual instruction, when appropriate, unless the district receives written notification of a family's desire to opt out due to privacy concerns. If a family declines virtual group instruction, the district will collaborate with the student's family to develop an alternative arrangement. Please feel free to reach out to your student's School Principal to discuss any concerns.

<u>Parent/Guardian Risk Acknowledgement</u> Notice Regarding Return to School

As the beginning of the academic year approaches, the Shippensburg Area School District wishes to address the challenges associated with returning to in-person instruction for our District staff, students, and parents. The novel coronavirus, COVID-19, is extremely contagious and continues to remain a worldwide pandemic by the World Health Organization. COVID-19 is believed to spread mainly from person-to-person contact and has had severe consequences for those that are especially vulnerable, such as senior citizens and individuals with underlying medical conditions. As a result, federal, state, and local governments and federal and state health agencies have made numerous recommendations over the past months to fight the spread of infection, including increased handwashing and social distancing measures to limit contact with others.

The District has put in place preventative measures recommended by the Centers for Disease Control and Prevention, Governor Wolf's Executive Orders, the Pennsylvania Department of Health and other agencies, as more fully outlined in the District's Health and Safety Plan, to reduce the spread of COVID-19 and to allow students and parents to feel comfortable about returning to in-person instruction within the school setting. Even with preventative measures in place, there are inherent risks as the risk of infection for COVID-19 exists and is difficult to control.

We need families, parents and students to acknowledge and understand the contagious nature of COVID-19 and the risk of infection and injury associated with use of District transportation, in person instruction, and participation in District programs and activities. We cannot guarantee that you or your children will not become infected with COVID-19 as a result of the aggressive nature in which this virus may spread. Families, parents and students must understand the potential for infection, injury, or even death as a result of COVID-19 that exists when using District transportation or participating in District instructional programs and activities. An inherent risk of exposure to COVID-19 exists in any place where people are present.

We understand your concerns, and the School District has taken enhanced health and safety measures to create the safest environment feasibly possible during this pandemic. We require that all students and their families follow all posted instructions as provided by the School District's Health and Safety Plan for the health and well-being of all.
