REGULAR MEETING MINUTES
MARCH 4, 2019 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on March 4, 2019 at 6:00 p.m. Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, Mr. Tim Matthews, Mr. Jimmie Johnson, and Mrs. Janie S. Downer, Superintendent/Principal were present.

Mrs. Linda Rogers called the meeting to order.

Mr. Jimmie Johnson gave the invocation.

Mrs. Linda Rogers recognized visitors.

The tentative agenda was approved by a motion made by Mr. Tim Matthews, seconded by Mr. Jimmie Johnson. The motion was approved unanimously.

The Board approved the Superintendent's personnel recommendation to rehire all certified teachers (listed on memo dated March 4, 2019) for 2019-2020 school year by a motion made by Mr. Jimmie Johnson, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to hire Ms. Sydney Carithers as a teacher by a motion made by Mr. Donald Brown, seconded by Mr. Jimmie Johnson. The motion was approved unanimously. (Pending Completion of Background Check)

The Board approved the recommendation of the Superintendent to hire Ms. Taylor Moore as a substitute teacher by a motion made by Mr. Donald Brown, seconded by Mr. Jimmie Johnson. The motion was approved unanimously. (Pending Completion of Background Check)

Mrs. Downer presented the Superintendent's report—commented on Dr. Ingram's career fair—great setup, the Whole Governance Board Training (3hrs) planning for a day in April, and Mrs. Pollock (absent for sickness) was not available to speak on students' testing. Special Education—Ms. Ellis commented the department was doing great and GO-IEP has started. Title I—(Mrs. Swain's dept.) Mrs. Downer

commented that SACS will be present on campus Tuesday and Wednesday to visit classrooms and to meet with Board members Wednesday at 8:15 a.m.
