Title VI Discrimination Complaint Form

Any person alleging discrimination on the basis of race, color, or national origin has a right to file a complaint within 180 days of the alleged discriminatory act. At the complainant's discretion, the complaint can be filed with the Bledsoe County School District, Tennessee Human Rights Commission, or the Tennessee Department of Treasury. If filed with the Bledsoe County School District, the complaint should be directed to the attention of the Director of Schools.

All complaints, written or verbal, should be accepted. In the event a complainant sets forth the allegations verbally and refuses to reduce such allegations to writing, the Human Resources Title VI Coordinator should document the details of the complaint to writing.
