RELEASE, WAIVER OF LIABILITY, AND COVENANT NOT TO SUE

(READ CAREFULLY BEFORE SIGNING)

I hereby acknowledge my awareness that my participation and that of my child(ren) in the UGA-FLL State Competition at the University of Georgia (UGA) Miller Learning Center (MLC) on February 1st, 2014 may expose us to risks of property damage, and bodily or personal injury, including death. I also agree that my child(ren) and I will at all times follow the directions of UGA faculty and staff during these programs.

Activities will include participations in the various FLL competition events, including the Opening and Awards Ceremonies at the Miller Learning Center. I have read and understand the attached schedule of events and all of my questions concerning these events have been answered. I understand that the risks that my child(ren) may encounter include, but are not limited to transportation accidents, burns, physical injury from accidental occurrences such as cuts, abrasions, scrapes and broken bones as well as other risks that may not be foreseeable. On behalf of my child(ren), I knowingly and freely assume any and all such risks and voluntarily participate in these activities.

In exchange for the use of equipment, materials, supplies and for my child(ren) and I being allowed to participate in this program, I hereby release and forever discharge UGA, the Board of Regents of the University System of Georgia, their members individually and their officers, agents and employees from any and all claims, demands, rights, expenses, actions, and causes of action, of whatever kind, arising from or by reason of any personal injury, bodily injury, property damage, or the consequences thereof, whether foreseeable or not, resulting from or in any way connected with my participation in this activity.

I further covenant and agree that for the consideration stated above, I will hold forever harmless and will not take legal action against UGA, the Board of Regents of the University System of Georgia, its members individually, and their officers, agents, and employees for any claim for damages arising or growing out of participation by my child(ren) and I in this program whether caused by negligence or otherwise.

I grant permission for my child(ren)'s and my likeness, image and voice to be recorded in any media during this program and to be used by UGA on behalf of the Board of Regents of the University System of Georgia in any publications, media, or technology now known of or hereafter developed in the future for any lawful purpose whatsoever without further permission from me. I understand I will not be compensated further for use of these recordings.
