

WEBSTER COUNTY BOARD OF EDUCATION
REGULAR SCHEDULED MEETING MINUTES
OCTOBER 10, 2016 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on October 10, 2016 at 6:00 p.m. Mrs. Linda Rogers, Mr. Donald Brown, Mrs. Mary Hinman, Mr. Nehemiah Stevens, Mr. Tim Matthews, and Mrs. Janie S. Downer, Superintendent/Principal were present.

Mrs. Linda Rogers called the meeting to order. Mrs. Linda Rogers gave the invocation. Mrs. Linda Rogers recognized visitors. No comments were given.

The Board approved the Local Board Training Plan by a motion made by Mr. Donald Brown, seconded by Mr. Tim Matthews. The motion was approved 4-1 with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Nehemiah Stevens opposed.

The Board approved the District Safety Plan by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved 4-1 with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Nehemiah Stevens abstained.

The Board approved the Superintendent's recommendation to hire Abbey Pilkington as a substitute teacher by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved 4-1 with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Nehemiah Stevens abstained. (Background Check Completed)

The Board approved the Superintendent's recommendation to remove Shondra King from Middle and Varsity girls basketball assistant coaching duties due to recent injuries (remove \$2000 supplement) by a motion made by Mr. Donald Brown, seconded by Mr. Tim Matthews. The motion was approved 4-1 with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Nehemiah Stevens opposed.

The Board approved the Superintendent's recommendation to add middle grade girls basketball assistant coaching duties to Sallie Minick (add \$500 supplement) by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved 4-1 with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, and Mr. Tim Matthews voting for the motion; Mr. Nehemiah Stevens opposed.

Mrs. Downer presented the Superintendent's report along with the Special Education report and the Title I report.

The meeting was adjourned by a motion made by Mr. Donald Brown, seconded by Mr. Tim Matthews. The motion was carried unanimously.
