LEVEL 3 VOLUNTEERS

Level 3 volunteers are non-district personnel who will have direct, unsupervised interaction with students. An example of this type of volunteer would be chaperones on overnight field trips and mentors who have unsupervised interaction with students.

Level 3 Volunteers Must have a background check completed prior to service. The secure volunteer background link can be found on the Randolph County School System website at www.randolph.k12.nc.us. Click on the Parents & Students banner, then click on the Secure Volunteer Background Link under Volunteer Resources.

NOTICE: Any person who is required to register as a sex offender cannot serve as a volunteer. Anyone who has charges pending or pled guilty to a felony may not be eligible to serve as a level 3 volunteer.
