Technology for Virtual Learning: As stated in the virtual meeting last night, technology has been ordered for all students and teachers (teacher devices arrived today), but the devices for students are scheduled to arrive on September 15th. For families without personal devices or internet connectivity, we've got you covered for as long as we need! See the information below:

1. <u>Students WITH devices and internet connectivity</u> will utilize an online Learning Management System (LMS) to access materials and instructional activities to engage in high-quality teaching and learning.

• Canvas is the Learning Management System for students K-12.

2. <u>Students WITHOUT devices or internet connectivity</u> will receive Learning Packets and will be expected to follow the same instructional schedule as students who do have devices. Learning Packets will be available for pick up at all schools on Friday, September 4th between 9:00 a.m. and 2:00 p.m. as follows:

Note: All persons should remain in vehicles. "Walk up" pick-ups are not allowed.

3. <u>Students WITHOUT devices or internet connectivity</u> must return completed packets on Friday of the same week between 8:00 and 2:00 p.m. using the same method as pick-up.

- New Packets will be available for pickup every Friday and should be returned the following Friday.
- The return of the packet will determine a student's attendance for that week of work.
- Parents should make sure that the student's name, grade, and school is on the front of learning packet.
- Special Education Students who do not have internet access will continue to receive support services through other methods.

Once all packets are received, assigned paraprofessionals or clerical staff will sort packets for processing to the school/teacher. Teachers will then review the packets and enter grades in Sam Spectra.

Device Insurance: For those who receive district technological devices (computer, hotspot), there is a \$25 insurance fee per device and covers the device in the event of damage. Parents do not have to get insurance on each device, but if something happens to the device, they will be responsible for the repairs and possible replacement. Failure to get the insurance and failure to pay for a damaged device will hinder registration, graduation, and also places the responsibility for continued learning solely on the parent. Parents do not have to use district devices; they can use their own devices if they have them, provided that those devices are able to connect to our instructional programs. Parents of multiple district students also do not have to opt for a district device for each child if they do not wish. Devices will be collected at the end of the school year.

Athletics: Fall Sports and Activities will move forward. The district will comply with MHSAA, CDC, and state guidelines in ensuring safe seasons for all participants. This decision was made with the input of parents of participants. However, no students will be begged, forced, or persuaded to participate. The Board of Trustees is requiring all participants to take a COVID-19 test prior to games/activities. The Board also reserves the right to cancel all activities at any time.
