# Minutes Andalusia City Board of Education BOARD MEETING Andalusia Elementary School Conference Room June 4, 2018

#### 6:00 p.m.

#### Presentation

#### **Status Change**

Brad Goldman, Social Studies Teacher at Andalusia High School to Social Studies Teacher/Interim Basketball Coach at Andalusia High School, effective August 1, 2018.

Walter Wytch made a motion to accept this status change and David Bryant seconded the motion.

Brenda Johnson, Assistant Principal at Andalusia Elementary School to Principal at Andalusia Elementary School effective July 1, 2018.

Walter Wytch made a motion to accept these status changes and David Bryant seconded the motion.

#### **Honors Degree**

Mrs. Ennis discussed a potential change to the honors math language in the Andalusia High School Registration Guide. Superintendent Watson recommended that the honors math policy be changed to say "must have pre calculus or higher level college math with SAT exemption".

The motion was made by Walter Wytch to approve this and Tommy Wright seconded the motion.

#### **Produce** Contract

The Board reviewed the Four Seasons produce renewal contract. Walter Wytch made a motion to approve the renewal of the contract and David Bryant seconded the motion.

#### **Facility** Assessment

Superintendent Watson provided copies of the Facility Assessment to the Board members. He provided an overview of the assessment that was requested by the City Council. After the Board had time to review the assessments, they were collected and will be presented to the City Council at their next Council Meeting.

#### **LED Board**

Superintendent Ted Watson discussed the LED/Video Board with the Board. It will be presented for a vote during the Consideration of Construction Items later in the meeting.

### Consideration Items

Superintendent Ted Watson presented a listing of construction items for consideration to the of Construction Board. The Board voted no to additional aluminum bleachers on the home side of the football stadium. The motion was made by Amy Dugger and David Bryant seconded the motion. The Board voted to allow the City to move the wall and maintenance shed and to have the ground graveled and sprigged for a cost of approximately \$15,000. The motion was made by Walter Wytch and seconded by Tommy Wright. The Board voted no to Alternate 8, Bar Joist for \$28,000. The motion was made by David Bryant and seconded by Tommy Wright. The Board voted to accept the gift of the LED/Video Board from the Public Educational Building Authority (PEBA) with an additional cost of the LED/Video Board being approximately \$8,000. The motion was made by Walter Wytch and seconded by David Bryant. In addition to the construction items for consideration, Superintendent Watson asked for permission to look into the possibility of contracting with someone with the knowledge and ability to run the LED/Video Board and incorporate this into a CTE type course. The motion was made by Walter Wytch and seconded by David Bryant.
