MINUTES

The called meeting of the Sumter County Board of Education was called to order by Chairman Michael Busman with the following other members present: Rick Barnes, Edith Green, Meda Krenson, and Jim Reid.

The agenda was unanimously approved on a motion by Ms. Edith Green; second by Mrs. Krenson.

The FY 2017 Rollback Calculation (Form PT32.1) along with the 2017 Final Millage Rate (18.224) and Five Year Tax Digest were unanimously approved recommended by the committee.


