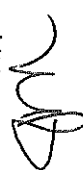

reflective of the organization that is in place now and we should update it as we do the policies.

- Mr. Wellman noted that at the Operations Committee meeting there was a discussion of the Facilities Manager being moved to the Assistant Superintendent's overview from the Superintendent and he asked Dr. Paddyfote to explain. Dr. Paddyfote said at one time the Board had two Assistant Superintendents, one for operational issues, now there is one Assistant with multiple responsibilities. She also said there is a close relative of the Director of Fiscal Services working under the Facilities Manager and so the line of authority was switched.

The motion passed unanimously.

F. Grants

1. 2010-11 District Consolidated Application for ESEA Federal Grants

Mr. Nichols moved to approve the 2010-2011 District Consolidated Application as part of the ESEA Federal Grant funds in the amount of \$243,783, seconded by Mrs. Thomas.

- Mrs. Tarascio-Latour asked for an overview of the ESEA grant. Dr. McLaughlin said this is a federal grant given to districts meeting the requirement of the number of students on free or reduced lunches. This is for Title I schools and the district must match the services provided at non-Title I schools.
- Mrs. Rigdon asked how much New Milford must contribute and Dr. McLaughlin said nothing.
- Mr. Lawson asked if this was a competitive grant and Dr. McLaughlin said it was not competitive grant at the moment.
- Mrs. Tarascio-Latour said if the schools needed to match the money for non-Title I schools where would that money come from. Dr. McLaughlin said it was not necessarily matching dollars but matching resources.
- Mrs. Rigdon asked what the dollar amount would be to meet the mandate. Dr. McLaughlin said there is a formula to determine Title I. Currently Title I schools are John Pettibone, Hill & Plain, Sarah Noble, and Schaghticoke. The money can only be used to

supplement in those schools.

- Mr. Lawson asked what the money was used on besides tutors and Dr. McLaughlin said it was also used for professional development.
- Mrs. Tarascio-Latour said if two of the three schools receive money, what does Northville receive. Dr. McLaughlin said tutors have been added at each of the Title I schools to help with reading and so the district needs to hire a tutor for Northville.
- Dr. Paddyfote asked if there was more money in this year's grant or the same as last year and Dr. McLaughlin said the amount is essentially the same as last year.
- Dr. McLaughlin noted that the same types of programs as last year are in place including tutors and professional development.
- Mr. Weinberg asked if new money needed to be found in the budget for this grant and Dr. McLaughlin said money has been allocated in this budget for tutors.

The motion passed unanimously.

G. Education Jobs Fund Grant

Mrs. Thomas moved to authorize the administration to hire two literacy coaches and one math coach from the Education Jobs Fund Grant as recommended by the Operations Committee, seconded by Mr. McSherry.

- Mr. Nichols asked Dr. Paddyfote to explain her proposal to spend some of this money.
- Dr. Paddyfote said she met with the central office staff to discuss how best to spend the money. Some in the central office favored keeping the money until next year expecting a difficult budget cycle. However, she and Dr. McLaughlin said after the approval of the Strategic Plan item number five which is about curriculum, there was a need to look at literacy and math coaches. She said the thought was if there were some teacher retirements, then coaches should be brought in to replace them. She said at the end of August, the schools made safe harbor which could lead to getting them off the needs improvement list. Schools that are in year five of improvement then

have to write a plan for alternate governance and in year six it has to be implemented.

- Dr. McLaughlin noted there is no support staff at New Milford High School for SRBI tiers II and III.
- Dr. Paddyfote said she originally agreed with not spending any of the money since the Education Cost Sharing grant for New Milford could be cut next year.
- Mr. Nichols said he understood safe harbor but asked how this would affect the grant and Dr. McLaughlin said she was not aware of any effect.
- Mr. Nichols asked what could happen with schools that are in their fifth or sixth year of needing improvement and Dr. McLaughlin said the implementation plans can be quite severe as in replacing administrators and teachers.
- Mr. Weinberg asked how much more value could be gained from hiring coaches versus hiring teachers. Dr. Paddyfote noted that the cuts at Schaghticoke included a team of teachers and the only way to add teachers there was to add a full team. She noted that all the students are already in established classrooms.
- Mr. Weinberg asked if the Town could take the money and earn some interest and Dr. Paddyfote said now the Town has to draw down on the funds versus just receiving a check.
- Mr. Lawson said this money presents this Board with the opportunity to reinstate teachers and an administrator, repeal pay to play, and refund those who have already paid for sports. He said this Board cut positions and instituted pay to play to fund positions and now should give it back and put teachers back in the classroom where they will have a direct impact on the students.
- Mr. Weinberg said he agreed with Mr. Lawson on hiring teachers and not coaches as teachers would have more impact than coaches.
- Mrs. Tarascio-Latour said her concern with hiring the coaches was they were going to be full time with benefits and New Milford would be spending money to hire them and train them and they would only be in place for two years. She asked if anyone had thought about the unemployment cost after year two.
- Mr. Lawson said he is concerned with next year's budget but he is more concerned with this year's budget. He said he didn't hear anything about job

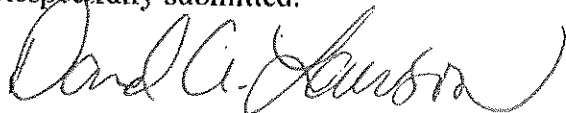
coaches at budget time. He said the schools reaching safe harbor is a good thing, and therefore, something must be working. He said if this Board did not spend the full \$700,000 then the Town Council might cut it at the next budget cycle.

- Mrs. Thomas noted that the school has never had any rainy day fund and this could be one. She said she has faith in the administration and staff and they all want these kids to succeed. She said the best way to help the students is to hire these coaches to help all the teachers.
- Dr. McLaughlin noted these coaches would be helping a lot of teachers modeling lessons in the classroom. They would be experts in reading or math.
- Mrs. Rigdon said trying something different was a good idea.
- Mr. Lawson said that the funds should be used now to reinstate teachers and repeal pay-to-play. He also suggested that job coaches could be hired for professional development days.
- Mr. Wellman asked if the money could be used to refund pay to play and Mr. Miller said he thought it could, but he would have to research it.
- Mr. Wellman asked if the money was refunded how much would that be for the year and Mr. Miller said it would be about \$125-\$130,000.
- Mr. Wellman said in conventional times, the Board could rely on having the money available for next year, but noted these are not conventional times. He said nothing would preclude the federal government from asking for the money back if it is not spent. Mr. Miller said it has never happened to his knowledge.
- Mr. McSherry said he was for the coaches and also saving some of the money for the future but said the Town Council would cut that money right from the top. He thought some of the money could also be used to hire para-educators and tutors.
- Mrs. Thomas said she liked that idea and thought that could come before Operations and Committee on Learning.
- Mrs. Faulenbach said this Board can't worry about the Town Council. She said this Board needs to be careful about spending all the money. She said the money should be spent to reach as many students as possible but she did not support spending all the

He said there are more subjects than reading and math and this Board is charged with educating the whole child. He asked how the success of the coaches was going to be measured. • Dr. McLaughlin said there was not a specific measure but the coaches and teachers could be asked to work with the 10% of students needing improvement. • Dr. Paddyfote noted these people are not going to be easy to find. She said these positions are cutting edge for New Milford. She noted these coaches were not in the budget before because the work on the strategic plan, strategy number five was ongoing. Three things happened that brought this forward – the strategic plan was approved in June, the test results came back in early August, and the district was notified of this grant in early September. <p>The motion passed 8-1.
