

WEBSTER COUNTY BOARD OF EDUCATION  
REGULAR MEETING MINUTES  
FEBRUARY 11, 2019 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on February 11, 2019 at 6:00 p.m. Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, Mr. Tim Matthews, Mr. Jimmie Johnson, and Mrs. Janie S. Downer, Superintendent/Principal were present.

Mrs. Linda Rogers called the meeting to order.

Mr. Jimmie Johnson gave the invocation.

Mrs. Linda Rogers recognized visitors.

The tentative agenda was approved with the amendment of adding to the agenda-#4 Approve to Compensate Mrs. Marcia Roberts for Long-Term Substitute in the Media Center at the Last Salary Rate Received Prior to Retirement (Mrs. Amanda Farr Estimating Maternity Leave in March) by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.
