Frank Boultinghouse, 228 Marshall Avenue, Gibbstown, NJ wanted to know why we were paying our Technology Coordinator over \$97,000.00 for 18 months of work?

Superintendent Combs responded that the first figure listed on the agenda is an amount for six months. He will not be paid that amount but it reflects the increase he deserved.

Scott Campbell added that the Technology Coordinator was the only person in the district who had a contract that ran from January 1 to December 31. In order to get him on-line with everyone else in the district, it was necessary to give him an increase for January 1, 2002 to June 30, 2002 and then have the back portion of the agreement fall on-line with everyone else in the district. Essentially, the second figure is for a twelve month period covering July 1, 2002 to June 30, 2003.

Anthony Rastelli, Memorial Avenue, Gibbstown, NJ, asked if there was any movement on the Italian Language being placed into the curriculum? Joseph Marcucci responded that as soon as the state aid figures come in, we will be able to come to a decision on programs. Until then, we have to wait to get a better idea of where we are heading.
