## **Superintendent's Report**:

- 1. Superintendent Lutz updated the board on the work at the Old School Center nearing completion.
- 2. The board was informed that 9 or 10 choir students will be attending honor choir at Concordia College in Moorhead.
- 3. Discussion was held regarding putting action on the addition of a one-act play program and a speech program at the Kelliher School on the agenda. Motion by Ed Gehlert, second by Ed Anderson to add them to the agenda as F-6. Motion passed unanimously.
- 4. There will be an open house at the Kelliher Library and Information Center on the 21st of December
- 5. Superintendent Lutz informed the board that he has been contacted by a dentist from Bigfork about the possibility of a satellite office at the Old School Center.
- 6. Superintendent Lutz informed the board that due to the number of students in Early Childhood with special needs, BRIC is requesting the district hire a Special Education paraprofessional. - 7. The possibility of adding an Ojibwe language curriculum as an enrichment program was discussed, with the board requesting the administration to do additional research in ways that it may be accomplished.
- 8. Superintendent Lutz informed the board that there has been a request from Judy Ross to be able to offer piano lessons in the school.
- 9. The date of the January board meeting will have to be rescheduled due to conflicts with the MN School Boards Association annual conference. January 9<sup>th</sup> was set for the next regular meeting.
- 10. Superintendent Lutz informed the board that Dave Hanson recommended that the district should consider purchasing a new bus this year, in addition to possibly trading in one or both SUVs.
