Lewis DeWeese, Chair, deferred the responsibility of chairing the meeting to Chad Galloway, Vice-Chair, who in turn called the meeting to order.

Motion by Lewis DeWeese, seconded by Chad Galloway, to go into Executive Session for the following purpose: to discuss or deliberate upon the appointment, employment, compensation, hiring, disciplinary action or dismissal, or periodic evaluation or rating of a public officer or employee or to interview applicants for the position of superintendent (O.C.G.A. 50-14-3(b)(2)). All members voted yes; motion carried.

Motion by Terry Bramlett, seconded by Bobby Bearden, to resume the regular meeting. All members voted yes; motion carried.

Chad Galloway, Vice-Chair, announced no action was taken during Executive Session.

Motion by Bobby Bearden, seconded by Terry Bramlett, to accept the resignation of Billy Joe Rice effective March 18, 2019. All members voted yes; motion carried.

Motion by Lewis DeWeese, seconded by Bobby Bearden, to approve Susan Wynn as an administrator pending completion of paperwork, criminal background check, and release of contract from the Colquitt County (Georgia) Board of Education. All members voted yes; motion carried.

Motion by Terry Bramlett, seconded by Mike Cole, to approve Theresa Brown's request for a reduction of days for the 2018-19 school year. Effective March 18, 2019, Ms. Brown will work 78% for the remainder of the 2018-2019 school year. All members voted yes; motion carried.

Motion by Bobby Bearden, seconded by Lewis DeWeese, to approve Jessica Derrick as a substitute for the Nutrition Department pending completion of paperwork and criminal background check. All members voted yes; motion carried.

Assistant Superintendent Robert Ensley provided information on the local board training scheduled for March 14, 2019. The training will begin at 4:30 p.m., and the regular business meeting will begin at 6:00 p.m.
