Board Elections

1. Amendment of Charter Bylaws to reflect an Ex-Officio CEO

Ms. Fairclough-Leslie made a motion to amend the REACS charter Bylaws to reflect the position of Ex-Officio CEO with no voting rights. Ms. C. Williams seconded the motion and all were in favor with no abstentions.

REACS Bylaws – Article III: Board of Trustees C. Election of Trustees 1. Election The Board shall elect the Trustees by the vote of a majority of the Trustees then in office, whether or not the number of



Trustees in offices is sufficient to constitute a quorum, or by the sole remaining Trustee. Trustees-elect assume office subject to approval by the Charter Entity. One Trustee position on the Board is reserved for a parent of a current student of the Charter School. The CEO of the school serves as an ex-officio non-voting member of the Board of Trustees.

- 2. Dr. L. Hamer made a motion to re-elect Ms. Fairclough-Leslie and Ms. Anglin to the REACS board. Ms. C. Williams seconded the motion and all were in favor with no abstentions.
- 3. Ms. Fairclough-Leslie made a motion to elect Dr. Hamer as the new Board Chair, Sylvia Fairclough-Leslie as Board Secretary, and Marcia Anglin as Board Treasurer. Ms. Fairclough-Leslie seconded the motion and all were in favor with no abstentions.
- 4. The board affirms that the newly elected or re-elected PTA President will serve one term on the REACS Board of Trustees.
