

WEBSTER COUNTY BOARD OF EDUCATION
SPECIAL CALLED MEETING MINUTES
MARCH 18, 2013 AT 6:00 P.M.

The Webster County Board of Education held a special called meeting on March 18, 2013 at 6:00 p.m. Mrs. Linda Rogers, Mr. Donald Brown, Dr. Sophronia Thompkins, Ms. LaToya Riggins, and Mr. Nehemiah Stevens were present.

Mrs. Linda Rogers called the meeting to order.

Mr. Nehemiah Stevens gave the invocation.

Mrs. Linda Rogers recognized visitors.

The Board approved the tentative agenda with the amendment of adding to the agenda-#2 Approve to accept Employment Resignation of Dorothy Crimes and #3 Approve to accept Employment Resignation of LeAnne Eason-by a motion made by Mr. Nehemiah Stevens, seconded by Dr. Sophronia Thompkins. The motion was approved unanimously.

The Board approved to accept Dorothy Crimes' resignation of employment by a motion made by Mr. Nehemiah Stevens, seconded by Ms. LaToya Riggins. The motion was approved 3-2, with Mr. Nehemiah Stevens, Ms. LaToya Riggins, and Dr. Sophronia Thompkins voting for the motion; Mrs. Linda Rogers and Mr. Donald Brown opposing.

The Board approved the resignation of employment from LeAnne Eason by a motion made by Mr. Nehemiah Stevens, seconded by Ms. LaToya Riggins. The motion was approved 3-2, with Mr. Nehemiah Stevens, Ms. LaToya Riggins, and Dr. Sophronia Thompkins voting for the motion; Mrs. Linda Rogers and Mr. Donald Brown opposing.

Discussion on hiring of Interim Superintendent took place at this time. Mrs. Linda Rogers announced three options for the process: 1) by hiring within the system, 2) by application, or 3) by experience.

Bill Sampson of GSBA presented the Board with information regarding the need for an Interim Superintendent and a list of possible candidates for an Interim Superintendent.

The Board approved to enter into executive session to discuss possible applicants by a motion made by Dr. Sophronia Thompkins, seconded by Mr. Nehemiah Stevens. The motion was approved unanimously.

The Board approved to exit out of executive session by a motion made by Mr. Nehemiah Stevens, seconded by Ms. LaToya Riggins. The motion was approved unanimously.

The Board approved to adjourn by a motion made by Mr. Nehemiah Stevens, seconded by Ms. LaToya Riggins. The motion was approved unanimously.
