What if...!

- ▶ What if your child had instant contact with a health care professional to address their immediate medical need?
- ► What if your child did not have to miss school days because the illness is caught early?
- ▶ What if you didn't have to wait for an appointment and didn't have to check your child out of school for a medical visit?
- ► Every child has the potential to be a C.A.T.S. patient once the paperwork is completed!

What is Telehealth?

- ► Telehealth uses computers, internet access, assessment tools, secure software, and camera devices to connect a health care provider with the patients who need them.
- ► These devices enable the provider to assess, diagnose, and treat health issues such as pink eye, ear infections, common cold, strep, flu, urinary tract infections, rashes, allergies, and lice.
- ► Testing supplies for strep, flu, and urinalysis will be available at all school locations offering telehealth visits.



Who can use **Care At The Schools (C.A.T.S.)**Telehealth?

Your C.A.T.S. provider is here to see ANY students or staff members who present to the school nurse with a concern that can be addressed by a telehealth visit.



When will C.A.T.S. services be available?

- ► Registration packets will be distributed at the beginning of the new school year so that sick students can get help as soon as they need it!
- ► Hours will be Monday through Friday, 8am-3pm.
- ▶ Students must have a completed C.A.T.S. Packet turned in to have access to telehealth services.

Please ask your school nurse for more information.



What is the cost of a C.A.T.S. visit?

- ▶ Students- \$0 (Insurance will be billed. Students with a copay, deductible or self-pay will not be responsible or billed for any visit fee).
- ► School staff- \$20 visit fee (Insurance will be billed. Any copay, deductible, or self-pay will be covered by the \$20).

How does Care At The Schools (C.A.T.S.) work?

- ▶ If your child becomes sick while at school, the school nurse will connect them with a medical provider through computer access (telehealth).
- ► The school nurse will <u>ALWAYS</u> contact you prior to connecting with the medical provider.
- ► The school nurse will <u>ALWAYS</u> be present during telehealth visits.
- ► Visit information will be forwarded to the patient's regular doctor if the appropriate form is complete.





- ▶ Because swab tests must be run in a lab, we are not able to perform testing in the schools this year.
- ► C.A.T.S. will be available to help school nurses determine whether a new sickness might be related to a COVID 19 infection.
 - ▶ If your child is already sick and needs a test, please do not send them to school.

What is the purpose of C.A.T.S.?

- ► To **promote** health by diagnosing and treating illnesses before sickness is serious.
- ► To decrease your time away from work or other important responsibilities.
- ► To identify any healthcare needs of your child within the school system.
- ► To assist families in establishing primary care if it is not already established.
