RE: Apply for Federal Programs and to receive comments from Stakeholders

Title I \$67,546

Purpose: **Title I, Part A** provides supplemental resources to help schools with high concentrations of students from low-income families acquire the knowledge and skills in the state content standards and to meet develop professional skills to be highly effective in providing instruction so that all students will be provided the opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps.

The purpose of Title I of ESSA is to provide all children significant opportunity to receive a fair, equitable, and high-quality education, and to close educational achievement gaps. Title I, Part A, supports campuses in implementing either a schoolwide program (SWP) or a targeted assistance program (TAP).

*Schoolwide - Provide all children significant opportunity to receive a fair, equitable, and high-Quality education, and to close educational achievement gaps.

*TIA Targeted Program: services only those “identified students” as having the greatest need for special assistance.

Tentative Plans based on the Comprehensive Needs Assessment (CNA in the Campus Improvement Plan (CIP):

Title IIA \$16,904

Purpose: Improve the quality and effectiveness of teachers, principals and other school leaders for improved instruction.

Tentative Plans based on the Comprehensive Needs Assessment (CNA in the Campus Improvement Plan (CIP):

LEA will use Transferability 100% REAP/Transferability to meet the intents and purposes of Title IA.

Title IV \$10,000

Purpose: to provide a well-rounded education to all students. Districts accepting these funds would address well-rounded educational opportunities, safe and healthy students and effective uses of technology.

Tentative Plans based on the Comprehensive Needs Assessment (CNA in the Campus Improvement Plan (CIP):

LEA will Transferability 100% of TIV to meet the intents and purposes of Title IA

Transferability:

Small/Rural districts are allowed the flexibility to use “REAP or Transferability” to use the noted funds to meet another program. If the LEA redirects 100% of a fund (IIA, IVA) by REAPs or Transferability then the LEA only has to meet the intents and purposes of the program the funds are being directed.

Example: If a district REAP/Transferability 100% of IIA and IVA funding into Title IA, then the district will meet the intents and purposes of Title IA only. This gives the district great flexibility.

If the district does not transfer 100% of a fund, then the intents and purposes must be met with the funds remaining in the original program fund.

Example: If a district REAPs/Transfers 60% of Title IIA to meet the intents and purposes of Title IA, the district must meet the intents and purposes of IIA with the remaining 40%.
