The Board approved the Superintendent's recommendation to move Mr. Gregory Britton from a substitute teacher to a paraprofessional (non-instructional) by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.

Mrs. Downer presented the Superintendent's report. Mrs. Downer notified the Board of a bus repair transfer of \$25,408.66 from general funds back into SPLOST. Mrs. Swain presented Title I information. Ms. Ellis presented Special Education information.
