HEALTH SCIENCE PROGRAM

YEAR 1: Foundations of Health Science (1 class period of the day)

YEAR 2: Patient Care Technician and/or Medical Coding (Each class is 1 period of the day)

YEAR 3: Health Science Internship (2 class periods of the day)

Students placed in Health Science Internship are required to provide their own transportation during two periods of the school day to a medical facility.

Foundations of Health Science (490007)

Fee: \$20.....Grades: 10-11th

A required one-credit course that introduces students to a wide range of health careers. Integrated academics combined with health care knowledge and skills provide the framework for a strong health care delivery system in the twenty-first century. This course is the prerequisite for all the health science courses. It is recommended for students who want to prepare for further study in an array of health-related fields at the postsecondary level.

PREREQUISITE: None (Foundation of Health Science will satisfy the Health Science graduation requirement.)

Patient Care Technician

Fee: \$20.....Grades: 11-12th (pending board approval)

Patient Care Technician is a one credit course that provides students the opportunity to become effective and efficient multi-skilled healthcare providers. Students will develop a working knowledge of advanced patient care skills, vital signs, 12-lead ECG/EKG's, oxygen therapy, basic phlebotomy via simulation, and specimen collection and processing.

PREREQUISITE: Foundations of Health Science

Medical Coding

Fee: \$20.....Grades: 11-12th (pending board approval)

Medical Coding is a one-credit course that is designed for students to gain knowledge about basic principles of coding and clinical classification systems. Students will study reimbursement methodologies, health records and data, health information requirements and standards, patient confidentiality, privacy, legal, and ethical issues. The course uses an integrated approach for teaching coding competencies by incorporating theory, lab, and application of skills. Medical Coding is recommended for senior level students after completing Medical Terminology and Human Body Structures and Functions course work. Students may be eligible to take a national certification exam in medical coding. Eligibility is based on individual certification agency requirements.

PREREQUISITE: Foundations of Health Science

Health Science Internship (490013)

Fee: \$100 (which includes HOSA fee).....Grades: 11-12th

A one or two-credit course designed for students in Grades 11 or 12. This course provides students with the knowledge and skills necessary for becoming a health care worker or for preparing students for postsecondary health care education 16 programs.

PREREQUISITE: Foundations of Health Science; Application from an ACTC Instructor; Access to transportation
