Administrators in each Murray County school populate most class rolls by heterogeneous grouping. Heterogeneous grouping refers to (a) grouping arrangements in which whole classes of students of varying intellectual ability learn together in one classroom or (b) within-classroom groupings in which students of varying abilities learn together in cooperative learning arrangements. This grouping practice is associated with efforts to assure high academic standards for all students and to allow all students the benefits of access to high-level instructional practices (National Middle School Association).

PROCEDURE TO REQUEST STUDENT PLACEMENT

An application for requesting student placement will be posted on the Murray County website (www.murray.k12.ga.us) before March 1 of each year. Parents must print this application from the website or pick up a copy from any school and fill in the information requested. The form may be mailed through the United States Postal Service to the student's school postmarked between March 15 and March 30, or the form may be dropped off at the student's assigned school between March 15 and March 30. Applications received after March 30 will not be considered. Please note that some teachers may change schools after March 30, which could impact the final choice for your child.

SYSTEM CRITERIA FOR SELECTION

System criteria will be used as the primary decision for placement.

1. Most classes will be composed of a heterogeneous group based on instructionally sound research.
2. No more than ten seats in each class can be taken by placed students.
3. **There is no guarantee that the first request will be honored, but efforts will be made to honor one of the requests.**

This form may be mailed through the United States Postal Service to the student's school postmarked between March 15 and March 30 or may be dropped off at the student's assigned school between March 15 and March 30. Applications received after March 30 will not be considered.
