## **RECOGNITION OF VISITORS**

Tammy Rodgers, elementary art teacher, reported to the board on the CCS Art Show which will be held at the Old Log Cabin in Westmont May 5 through 24, 2019. She also noted that the museum offers art camps over the summer for students.
