

Board Members Present Board members present for the regular meeting on October 18, 2016 were Mehrens, Kroenke, Eckhoff, and Parrott. Beaman, Sell, and Yearout were absent.

Call to Order President Mehrens declared a quorum present and called the meeting to order at 7:00 P.M.

Mr. Smith reviewed various bills and presented American Fidelity as the district's Section 125 Administrator effective January 1, 2017. Mr. Smith also shared information regarding the 2016-17 bus routes and presented the information for approval. Administrator Reports Mr. Smith shared that the most current assessed valuation figures shows an increase of \$189,000. The district K-12 enrollment from the September 2016 shows a small decrease to 486 students. Mr. Smith reported that the food service program is still going very well and updated the board on roofing issues at the Preschool.

At 7:20 PM, Mr. Yearout arrived at the meeting.

Mr. Spunaugle reported that the volleyball districts continue tonight in Stover. The high school attendance percentage is at 95.3%. JV football had an undefeated season. JH volleyball finished 4th in the conference. FFA students leave tomorrow for National FFA Convention. FCCLA attended the Fall Leadership Conference at Tan-Tar-A last weekend. HS Football plays this Friday hosting the first round of districts. There will be a tailgate party sponsored by the band students beginning at 5:00 Friday.

Mrs. Eifert reported that the elementary enrollment is currently at 265 with attendance at 97%. Sarah Beaman is in Kansas this week to get our therapy dog, Roscoe. Dyslexia training is being held, and all elementary students will be screened.
