

WEBSTER COUNTY BOARD OF EDUCATION  
REGULAR MEETING MINUTES  
FEBRUARY 8, 2016 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on February 8, 2016 at 6:00 p.m. Mrs. Linda Rogers, Mr. Donald Brown, Mrs. Mary Hinman, Mr. Tim Matthews, and Mrs. Janie S. Downer, Superintendent/Principal were present. Mr. Nehemiah Stevens was absent.

Mrs. Linda Rogers called the meeting to order.

Mrs. Linda Rogers gave the invocation.

Mrs. Linda Rogers recognized visitors.

The tentative agenda was approved with the amendment of adding to the agenda—#4 Approve FBLA members to attend the State Conference in Athens—by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved unanimously.

The January 2016 financial report was not available due to accounting software replacement.

The January 11, 2016 regular meeting minutes were approved by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.

The motion was approved 2-2-1 with Mr. Donald Brown and Mr. Tim Matthews voting for the motion; Mrs. Linda Rogers and Mrs. Mary Hinman abstained; Mr. Nehemiah Stevens was absent.

The Board approved the gun safety training (April 8<sup>th</sup>) sponsored by the sheriff's department by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board opened the sealed bid received for a new heating and cooling unit in school's cafeteria. After discussion, the Board tabled accepting the bid.

The Board approved to purchase server for BOE with ESPLOST funds by a motion made by Mrs. Mary Hinman, seconded by Mr. Tim Matthews. The motion was approved unanimously.

The Board approved to compensate Johnnie Williams (book) and James McCullough (clock) \$25 per home game for basketball service by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved unanimously. It was requested by the Board to vote on this approval prior to October rather than end of season.

The Board approved the recommendation of the Superintendent to rehire John Greene as Administrator(Elementary/Middle-12 months) for 2016-2017 by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to rehire Dorothy Crimes as Administrator (High School-12 months) for 2016-2017 by a motion made by Mr. Donald Brown, seconded by Mr. Tim Matthews. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to rehire LeAnne Smith as Administrator (Curriculum/Programs-12 months) for 2016-2017 by a motion made by Mr. Tim Matthews, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the recommendation of the Superintendent to rehire Jamie McCullough as Athletic Director /Academic Teacher for 2016-2017 by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown.The motion was approved unanimously.
