Violations Comments

Violation #22. Cold holding temperatures

Milk cartons in serving area were found to be 50F. All time/temperature control foods in cold holding must be held at or below 41F or time must be used as a control.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #55. Facilities installed, maintained, & clean

Large crack between tiles next to 3 comp sink. This should be resealed.

CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.
