Any reference contained herein to student(s) shall refer to the children listed above.

In consideration of the acceptance and enrollment in Tunica Academy of said student(s), the undersigned agrees to pay the required fees and tuition as set forth below and agrees to be bound by the terms and conditions set forth herein.

2. Payment: I agree to pay to Tunica Academy the applicable tuition and fees set forth above for each of the above student(s) enrolled in Tunica Academy as follows:

a. Payment options: Following registration, I agree to pay the balance of tuition owing for each of my students as follows: (select one option below)

- Payment in full: Tuition shall be paid in a lump sum payment on or before July 2, 2020
- Automatic credit card payment: Tuition shall be made in 11 equal monthly payments beginning August 1<sup>st</sup> charged to a debit card or major credit card. There will be a 3% handling fee on all transactions to the parent for I authorize Tunica Academy to automatically make said charges after the first day of the respective month.

- Check: Tuition shall be made by 11 checks made payable to Tunica Academy in equal amounts with one check postdated for the first day of each month from August 1<sup>st</sup> through June 1<sup>st</sup>. By selecting this option, I further agree to provide a major credit card and consent to it automatically being charged with delinquent payments in the event a check is not honored.

3. Continuing Obligation: Once the school year commences on July 2, 2020, my financial obligation to Tunica Academy to pay the tuition and fees set forth above is unconditional, and no portion of the funds paid will be refunded or cancelled, notwithstanding the subsequent absence, withdrawal, or dismissal of the student(s) from Tunica Academy. My obligation shall only be terminated in the event: (1) the student's residence is changed to a location which is greater than a distance of 90 miles from the school; or (2) the student is medically unable to attend Tunica Academy for a period of more than 60 days.

4. Delinquency: I agree that in the event tuition and/or fee payments become delinquent for a period of more than 30 days then Tunica Academy may at its option (1) withhold the student(s) from classes and extracurricular activities until the delinquency is cured; (2) dismiss the student(s); and/or (3) withhold release of transcripts and graduation diplomas until the delinquency is cured.

5. Student Handbook: By execution of this Contract, I, the undersigned on behalf of my student(s) and myself, approve, affirm, accept and agree to the terms, conditions, obligations, dress code and policies set forth in the Tunica Academy Student Handbook which is available on the Tunica Academy website at [www.tunicaacademy.com](http://www.tunicaacademy.com). I further agree that the Student Handbook may be altered or amended by the administration of Tunica Academy without notice and that my student(s) and I shall be subject to such alterations and amendments as of the date they are published on the foregoing website.

6. Application of Student Handbook: I understand that the provisions of the Tunica Academy Student Handbook shall be applicable to all students, and I understand that it is the policy of Tunica Academy not to grant any waiver or special exception for any student from the obligations or provisions set forth in the Student Handbook unless legally required. Accordingly, I agree that my student(s) and I shall be subject to all provisions set forth in the Student Handbook, including the provisions on discipline and corporal punishment, as currently stated in the Student Handbook and as amended in the future. Furthermore, I give my express consent for my student(s) to be subject to the disciplinary regime set forth in the Student Handbook, including corporal punishment. I further agree that any past waiver or agreement which contradicts any provision of the Student Handbook regarding my student(s) is null and void.

7. Indemnification: I unconditionally agree to immediately fully indemnify Tunica Academy for any and all destruction or damages caused by my student(s) or me to any building, equipment, books, computer software, or other items of school property, normal wear and tear excepted.

8. Photography: I hereby consent to the use of school photography which may include use of my student(s) image in school publications, newsletters, web pages, calendars, occasional news releases, or other promotions uses. I agree that Tunica Academy does not need to notify me or compensate me or my student(s) in the event of any such use.

9. Extent of Obligation: Each of the undersigned agrees that they are joint and severally liable for all of the obligations and liabilities agreed to in this Contract. The undersigned further agrees to pay all reasonable attorney's fees and costs incurred by Tunica Academy in the event of default of the undersigned.

10. Legal Contract: This is a binding legal document. If any portion of this instrument is determined by a court of law to be void or invalid, all remaining provisions shall remain in full force and effect.

11. Entire Agreement: It is expressly understood and agreed that this Contract contains the entire understanding and agreement of the parties and other representations, whether written or oral, are not part of this contract. It is further agreed that any and all amendments or alterations to this contract shall be in writing and signed by the undersigned and the Headmaster of Tunica Academy. The undersigned further acknowledges that he/she is fully aware of and completely understands and comprehends the terms contained herein.

12. Signatures: The undersigned agree(s) to the foregoing Enrollment Contract and the terms and conditions thereof as set forth therein. (Please note that all custodial parents must sign. If you have sole custody or are a guardian, please make available to the headmaster a copy of the court order or decree awarding custody.) **In the event of a third party becoming financially responsible for tuition and fees for students in this contract, the financially responsible party must sign below and be henceforth held responsible for tuition and fees for the life of this contract.**
