Dorchester School District Four Title I, Part A Parent Involvement Policy

Goal 1: The district will foster effective parent involvement strategies and support partnerships among schools, parents, and the community to improve student achievement.

- 1. Coordinate Title I, Part A parent involvement activities with other district-level programs.
- 2. Maintain a district-level Title I Parent Involvement Committee to promote parent involvement in the Title I Part, A schools.

- 6. Ensure that parents of children with disabilities or limited English proficiency have the same access as other parents including information in a language and form they can understand.
- 7. Provide information on adult literacy training available in the community.
- 8. Encourage the formation of partnerships between schools and local businesses that include roles for parents.
- 9. Provide training and resources for parents to learn about child development, child rearing practices, and other strategies that are designed to help parents become full partners in the education of their children.
- 10. Assist school staff in developing volunteer opportunities for parents.
- 11. Provide information to participating parents regarding such areas as national, state, and local education goals, including parents' rights as defined by the No Child Left Behind Act of 2001 (the most recent reauthorization of the Elementary and Secondary Education Act of 1965).
- 12. Where possible, provide additional support for parent involvement at the request of participating Title I, Part A schools and parents.

Goal 2: The district will conduct, with the involvement of parents, ongoing evaluation of the content and effectiveness of the parent involvement policy as it relates to strategies for increasing parent participation and identifying barriers to greater parent participation.

- 1. Monitor each Title I, Part A school to ensure that the following tasks are performed:
 - i. Provide information to parents about the school's programs and the academic progress of their children;
 - ii. Provide training for parents on working with their children to improve academic achievement;
 - iii. Convene an annual meeting to inform parents more specifically about the school's Title I, Part A schoolwide plan;
 - iv. Include parent participation in the annual meeting(s) designated for planning the next school year's Title I, Part A schoolwide plan;
 - v. Develop, revise as needed, and disseminate a school parent involvement policy and a School-Parent Compact on an annual basis; and
 - vi. Offer flexible meeting times for parents.
- 2. Develop and implement procedures for collecting parent participation documentation such as sign-in lists for workshops, meetings, and conferences; schedules; brochures; meeting notes; and other means as appropriate throughout the school year.
- 3. Provide parents with an opportunity to provide feedback and suggestions on improving district and school effectiveness through participation in an annual district-administered survey.
- 4. Provide an opportunity for parents to assist in the development of the evaluation procedures, including the analysis of data collected.
- 5. Use findings from the evaluation process to do the following:
 - i. Revise the district parent involvement policy as necessary;
 - ii. Make recommendations to each participating Title I, Part A school regarding revisions to the school parent involvement policy and School-Parent Compact; and
 - iii. Provide suggestions to the district and schools for developing additional improvement policies, as they relate to parent involvement.
