





#### **REOPENING OPTIONS FOR 2020-2021**

Jefferson County School District

#### OPTION 1: TRADITIONAL SCHEDULE



All staff will return on August 4-7, 2020, and receive personal protective equipment and professional development.



All students will return on August 10, 2020.



No impact to student schedules or extracurricular activities.

# OPTION 2: HYBRID SCHEDULE A

All staff will return on August 4-7, 2020, and receive personal protective equipment and professional development.

Elementary students (PreK-6) report to school Monday–Friday with limited schedules to avoid groups of students from mixing and promote social distancing.

Secondary students report to school on an A/B schedule in order to depopulate the schools and promote social distancing. Students will rotate between in–person and online learning platforms.

Additional protocols will be implemented to conduct screenings, sanitize high-touch areas, arrival/dismissal times will be modified and meals will be served in classrooms.

# OPTION 3: HYBRID SCHEDULE B

All staff will return on August 4-7, 2020, and receive personal protective equipment and professional development.

Elementary students (PreK-6) report to school on an A/B schedule. In order to depopulate the schools, half of the elementary students would report on Monday & Wednesday and half on Tuesday & Thursday, with special classes on Friday. Virtual learning would be provided on alternating days and selective special area classes will be taught.

Secondary students report to school on an A/B schedule in order to depopulate the schools and promote social distancing. Students will rotate between in–person and online learning platforms.

# OPTION 4: HYBIRD SCHEDULE C

All staff will return on August 4-7, 2020, and receive personal protective equipment and professional development.

Elementary and secondary students (PreK-12) report to school Monday–Friday for half a day. In order to depopulate the schools, certain grade levels would report in the morning and the other grade levels in the afternoon. Virtual learning would be provided during the time students would be at home.

# OPTION 5: TIGERS VIRTUAL ACADEMY

All staff will return on August 4-7, 2020, and receive professional development.

Students in grades PreK-8 will utilize I-Ready as the digital curricula for virtual learning and grades 9-12 will utilize Classworks. The instruction will be powered through Canvas.

Teachers will facilitate virtual instruction by adhering to a list of non-negotiables for engaging students in the online experience. This will ensure consistency across the district. Continuous professional development will be provided to ensure that best practices are utilized to support students' instructional needs.

**OPTION 6: BEGIN** THE YEAR IN AN IN-PERSON MODEL AND **TRANSITION TO** VIRTUAL MODEL **DUE TO AN OUTBREAK** 

Staff would continue to report to schools if possible to continue teaching online.

Students in grades PreK-8 will utilize I-Ready as the digital curricula for virtual learning and grades 9-12 will utilize Classworks. The instruction will be powered through Canvas.

Schools would resume in-person instruction as soon as we were cleared to do so.

#### ADDITIONAL CONSIDERATIONS

We will be prepared to support families who may need to continue the virtual academy in August due to individual medical needs and/or concerns.

Students may be asked to wear masks during bus transportation and arrival/dismissal times when social distancing cannot be achieved.

Students will be asked to bring water bottles to school as water fountains will not be accessible but water bottle refill stations will be available.

All options, other than Option 1, will restrict visitors from entering our schools and parent deliveries during the school day.
