- **Equipment rental fee of \$10.99 per month. In addition to any applicable taxes, each order will be assessed a monthly recurring carrier cost recovery fee of \$5.44 per month.**
- **Speeds up to 25 Mbps for \$50/mo (plus taxes) for 6 months - unlimited data**
- **Speeds up to 50 Mbps for \$60/mo (where available) for 6 months - unlimited data**
- **Price includes autopay, without it's an additional \$5/month**
- **After 6 months of service, bill increases by \$10/month. Offer good until 5/25/2020**

XFINITY/Comcast

- Limited to small parts of Postfalls/CDA area and Plummer
- Free mobile hotspots nationwide for 60 days
- New internet essentials customers receive 2 free months of internet services which is available to all qualified low-income households for \$9.95/month + tax. Must apply by 4/30/2020. For all new and existing internet essentials customers, the speed of the service increased to 25Mbps/down and 3Mbps/up

T-MOBILE

- All current T-Mobile and Metro plans have unlimited smartphone data for the next 60 days
- Similarly all of those customers are getting an additional 20GB of mobile hotspot/tethering services for the next 60 days (10GB/month for 2 months)
- Increasing data allowance at no charge to schools and students using EmpowerED digital learning program to ensure each participant has access to at least 20GB of data per month for next 60 days
- Dial 611 from your phone to speak to Care for additional information or plan changes
- As of 3/16/2020 they stated they do *NOT* have an offer available for 60 days of free service and encourage consumers to be cautious of social media stating otherwise

Verizon

- Waiving* activation and upgrade fees (via a waiver credited at time of purchase or on next bill)
- No current offers for mobile hotspot or Jetpack services for students
- Waiving voice service charges for current Lifeline customers

AT&T

(No Idaho coverage for home internet, but leaving it up as info for distance learning students and to use as reference when other providers don't have offers)

- All AT&T consumer home internet wireline customers, as well as Fixed Wireless Internet, can use unlimited internet data.

- Offering internet access for qualifying limited income households at \$10 a month through [Access from AT&T program](#). Expanded eligibility to Access from AT&T to households participating in the NSLP.
- New customers receiving two free months of service
 - No installation fee
 - No contract
 - No deposit
 - Free in-home WiFi

Lifeline Program (Federal)

- **A federally funded program that lowers the monthly cost of phone or internet services.**
- Lifeline typically provides up to a \$9.25 monthly discount on service for eligible low-income subscribers. Subscribers may receive a Lifeline discount on either a wireline or a wireless service, but they may not receive a discount on both services at the same time. Lifeline also supports broadband Internet access service and broadband-voice bundles. FCC rules prohibit more than one Lifeline service per household.
- **Qualifying is the first step. Requires an application with personally identifiable information.**
