A. Superintendent Report

- Operations A change was made to all the essential workers' work schedules (custodians, maintenance, grounds, cooks and bus drivers); they will be off on Wednesdays, working 4 days a week.
- Instruction- Audra Bluehouse reported students progress, the District started with a 78% failure rate and currently we are at 47%. Contributing to the difference was that the grading scale and the workload for both students and teachers have been changed. The daily attendance rate is at 95% and chronic absenteeism is at 5% rate.
 - Dr. Toni Hull continues to provide encouragement and support to teachers and principals.
- <u>COVID-19 update NMPED</u> is rolling out a new program called a VAULT
 Program: All schools that have students on campus (for the hybrid instructional
 model, for full re-entry (when allowed), for special education small group instruction,
 for athletics or for other purposes) will have staff that regularly visit the campus
 participate in 10% weekly surveillance testing (saliva-based testing). At this time the

District is not in a position to move forward with students physically attending school.
