MINUTES

The regular meeting of the Sumter County Board of Education was called to order by Superintendent, Dr. Torrance Choates with the following board members present: Rick Barnes, Abbis Bivins, Carolyn Hamilton, Patricia Harris, Vincent Kearse, Jim Reid and Sylvia Roland.

A moment of silence was observed.

BOARD ELECTIONS

As required by policy, the annual board elections for chairman and vice chairman were conducted. Superintendent Choates declared all positions open and asked for nominations for chairman. Mr. Reid nominated Mr. Barnes. Ms. Bivins nominated Mrs. Harris. Mr. Barnes received five votes (Mr.Reid, Mr. Kearse, Mrs. Harris, Mrs. Hamilton & Mrs. Roland). Mrs. Harris received one vote (Ms. Bivins).

Mr. Barnes assumed the office of chairman and asked for nominations for vice chairman. Mr. Kearse nominated Mrs. Hamilton. Ms. Bivins nominated Mrs. Harris. Mrs. Hamilton received six votes Mr. Kearse, Mrs. Harris, Mrs. Hamilton, Mrs. Roland, Mr. Reid & Mr. Barnes. Mrs. Harris received one vote (Ms. Bivins). Mrs. Hamilton will serve as vice chair.

The chairman called for nominations for school board attorney for school matters. Mrs. Hamilton nominated the law firm of Harben, Hartley and Hawkins. The nomination was approved unanimously.

Mr. Reid nominated Gatweeod, Skippper and Rambo for local matters. The nomination was unanimously approved.

The Americus-Times Recorder was unanimously approved as the weekly legal organ on a recommendation by Mrs. Roland.

A motion was made by Mr. Reid to adopt the agenda; second by Ms. Bivins; motion carried unanimously.

The consent agenda including minutes of the meeting held on December 10, 2020 was unanimously approved on a motion by Mrs. Roland; second by Mrs. Hamilton.
