Welcome to the CCP/ Camptonville School After School Receation Program. Our goal is to provide a safe, nurturing, and enriching environment for children after school. Additionally, we strive to make the program affordable for all that wish to participate.

Enrollment:

It is very important that if you choose to utilize the Recreation Program that you sign your child up. This insures staff knows what days to expect them. The enrollment process includes a signed permission slip to attend, and an enrollment contract. Extra copies of both will be located in the school office, or on site with After School Recreation Program staff. If you have an emergency, and need to send your child who is not enrolled, feel free to call the office and see if space is available for that day. This will be a drop-in, and we ask that when you pick up your child you sign the required forms, and pay for that day.

Rates and Payments:


The cost for the Recreation Program is \$10.00 a day. For families with more than one child, it is \$10.00 for the first child, and \$5.00 for each additional child. If your child will be attending after Interventions, or Cougar Club, the cost for that last hour is \$5.00. Payments can be made to onsite staff, and can be in the form of cash or check. Please make all checks payable to CCP. Receipts will be issued upon payment. Timely payments should be made weekly, this insures we keep the program going. Families that are experiencing hardships may qualify for financial assistance. If you need assistance please feel free to discuss this privately with staff.

Late Pick-ups:

The Recreation Program has established hours of 2:45 to 5:00, Tuesday - Thursday. We ask that your child be picked up on time, additionally we would like parents to be aware that three late pick-ups may be cause for termination of your child's participation in the program. If your child has permission to walk home they will be released promptly at 5:00.

Homework Policy:

Homework time is required everyday between 3:00 and 3:40. During this time assistance is offered to those children that need it. This is a good time for older children to complete school projects that may require use of technology. Additionally, this is a good time for students to do their required daily reading for class.



Snacks:
Snacks will be provided upon arrival to the After School Program, and will follow the school's wellness policy.
Allergies:
Please make staff aware of any allergies your child has, as well as any health concerns. In addition, if your child has several food allergies you may want to pack them a special snack.
Behavior:
It is vital that there is a line of open communication between staff and parents so that when behavioral issues arise they can be solved quickly, and effectively, together. All students are required to follow all school rules while attending the CCP/ Camptonville School After School Program. Failure to do so may result in suspension from the program.
Minimum days and Holidays:
There is no Recreation Program on minimum days, or holidays.
