Schedule for Re-entry

The 1st day for students will be Tuesday, September 8th. In order for our students and staff to effectively transition back to the school setting it is important that we bring back students by grade level to get acclimated to new protocol and processes. The schedule is:

- September 8thGrades 3,5,6,8,9,and 12 attend
 - September 10thGrades 1, 2,4,7,10,11 attend
 - September 11thAll Students 1st -12th attend
 - September 14thStudents in Kindergarten A Group attend only
 - September 15thStudents in Kindergarten B Group attend only
 - September 17thAll Kindergarten attend
- Pre-K teachers will contact parents about start dates for Pre-K students

Safety Upgrades

- Multiple water bottle filling stations will be installed at each school for students to fill personal water bottles
- Each student will be given multiple cloth facemasks
- Hand sanitizer will be available in all rooms
- Each school will have a well and sick nurses room to separate well and sick nurse visits

Weekly Schedule

Monday, Tuesday, Thursday, Friday – Traditional In Person Learning

Wednesday- Remote Learning

Health and Safety Protocols

- Buses will have hand sanitizer dispensers
- Buses will be cleaned between each run
- Custodians will be trained on cleaning high touch areas
- Students will be given several handwashing breaks
- Each classroom will be equipped with hand sanitizer for all students
- At TCHS/TCMS students will sanitize high touch areas between classes
- All hallways and restrooms will be marked to maintain social distancing
- Students 9-yrs old and older will wear mask anytime outside of the classroom, inside the building
- All students will be screened daily with the WVDE Re-entry Screening Tool
- All Schools will limit visitors into the buildings daily

Tyler County Attendance Options

Option 1 (In-Person Learning Pre-K-12)

Students will attend school Mondays, Tuesdays, Thursday's and Friday's. On Wednesday's, students will stay home and complete school work. This work will not need internet access for students to complete.

Option 2 (West Virginia Department of education Virtual Schools Program (K-12)

Tyler County Schools will utilize the West Virginia Virtual Schools program (WVVS) to facilitate the required virtual option for students in grades K-12 with a teacher provided by the West Virginia Department of Education. Quality internet access is a must when choosing this option for your child's education. Tyler County Schools will provide a mentor to act as a liaison for your student. Please note that if your student chooses this option of delivery they have 14 days to try it and still return to In-Person school if it is not the best method of instruction for them. After the 14 days students are required to complete 9 weeks of virtual classes before returning to Traditional In-Person Learning. There is a cost to families who choose the virtual school pathway for their students. Full Time Remote Learning- (Governor's Orders Only)

Remote Learning will only occur if the prevalence of COVID-19 causes the governor to suspend in-person instruction. Tyler County Schools are prepared to transition to remote delivery in the event a COVID-19 outbreak requires the temporary, short-term closure of a particular school.
