Due to the population of students enrolled in Monroe School and the school being housed in a correctional facility engagement from outside agencies is limited. In creating this plan OYA staff and OYA medical staff were consulted. The plan also takes into account the safety protocols within the facility. In addition, the plan was shared with ODE and the local health office to provide input on ensuring a safe school reopening.

In addition, OYA staff and school staff will assist in ensuring distancing is followed. All staff and students are encouraged to social distance. Physical distancing will be monitored by Megan Hunter, Chad Bradach, and Char Bradach.</p> <p>Training for all staff will be provided by OYA medical staff. This training will include proper hygiene, disinfecting practices, and other ways to reduce the spread of Covid-19. This training will be for all school staff. Michelle Schwarzin, OYA nurse, will supply training. She will also help advise on additional safety measures when needed.</p> <p>Disinfecting of space- All spaces will be disinfected throughout the day. In addition, additional deep cleaning will occur each week. Cleaning will be performed by OYA. School staff will assist between classes, at the end of each day, etc.</p> <p>If concerns of protocol, face coverings, etc. occur school staff should report to Megan Hunter. These concerns be anonymous and lead to improved practices.</p> <p>Protocol for Local Health: OYA will communicate with LPHA in regards to cases within the facility. **Hybrid/Onsite Plan**

Each morning, GLC staff will perform a visual screening. If a youth shows any symptoms youth will be tested by OYA nursing staff. If the youth tests positive, they will be moved to medical isolation and complete school in isolation.

If a student is to become ill, the following process will be followed:

- Student will be isolated in medical isolation within the correctional facility (OYA will intervene and keep school staff up to date)
- OYA will contact those who were exposed to the positive individual
- OYA superintendent will communicate with the school principal regarding the cases and contact tracing
- OYA will communicate with LPHA regarding potential Covid-19 cases.
- The student will participate in online learning while quarantined
- The school principal will communicate to school staff regarding students affected.

All contact tracing is completed by OYA via video review and JJIS logs of student movement.

OYA tracks all visitors and contractors entering the facility. This is recorded by OYA.

OYA works closely with school staff, OHA, and Local health professionals each time there is a case within the facility. The response is based on the chances of spread.

The facility does have some youth who have asthma that is treated by medical staff.</p> <p>If a student is at high risk, they will be placed into medical quarantine and participate in distance learning. OYA will notify school staff if a student is in this category.</p> <p>OYA medical staff will continue to work with all students in regards to any medical conditions, needs, etc.</p>

<ul style="list-style-type: none"> <li>☒ Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require <b>use of all space</b> in the calculation. This also applies for professional development and staff gatherings. If implementing Learning Outside guidance, establish an outside learning space for learning that maintains minimum 35 square feet per person. <ul style="list-style-type: none"> <li>• Within this design, educators should have their own minimum of 35 square feet and the design of the learning environment must allow for some ability for the educator to move through the room efficiently and carefully without breaking 6 feet of physical distance to the maximum extent feasible.</li> </ul> </li> <li>☒ Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.</li> <li>☒ Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.</li> <li>☒ Schedule modifications to limit the number of students in the building or outside learning space (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).</li> <li>☒ Plan for students who will need additional support in learning how to maintain physical distancing requirements. As cohort groups increase in size, the risk of spreading disease increases.</li> </ul> </li> <li>☒ Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational</li> </ul>	<p>Monroe School will follow OYA’s phase requirements when cohorting students. The phases specify what contact youth can have with one another. The school will maintain 35 square feet within the shops.</p> <p>The school will use the various locations within the facility to include: mechanics shop, woodshop, living units. These spaces will only allow small groups of students to ensure appropriate social distancing.</p>

Schools must plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure. Cohorts may change week-to-week, but must be stable within the educational week.</p> <ul style="list-style-type: none"> <li>☒ Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the <b>Ready Schools, Safe Learners</b> guidance).</li> <li>☒ Minimize interaction between students in different stable cohorts (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.</li> <li>☒ Cleaning and sanitizing surfaces (e.g., desks, dry erase boards, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.</li> <li>☒ Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, grade-level academic content standards<sup>5</sup>, and peers.</li> <li>☒ Minimize the number of staff that interact with each cohort to the extent possible, staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.</li> <li>☒ Elementary staff who interact with multiple cohorts (music, PE, library, paraprofessionals who provide supervision at recesses, etc.) should have schedules altered to reduce the number of cohorts/students they interact within a week. Consider having these staff engage via technology, altering duties so that they are not in close contact with students in multiple cohorts, or adjust schedules to reduce contacts.</li> </ul>	<p>The school schedule will allow for appropriate contact tracing and student daily logs.</p> <p>The school has eight employees who work with all youth. Employees will use hand washing and sanitizer to the best of their ability to reduce spread.</p>

Training could be accomplished through all staff webinar, narrated slide decks, online video, using professional learning communities, or mailing handouts with discussion. OYA will continue to communicate with probation officers, families, and others in regards to the students and prevention activities to reduce the spread of Covid-19.</p> <p>OYA has provided families:  Letters  Notification to probation officers  Phone calls to families</p> <p>OYA will continue to share information with families in regards to school. If a student contracts Covid-19 or is quarantined, OYA will notify families.</p> <p>All cases within the facility are shared by OYA.</p>

<sup>4</sup> The cohort limit is focused on the students experience and their limit of 100 people includes every person they come into contact with, including staff. There is not a limitation for staff in cohort size while care should be given to design and attention to the additional requirements.

<sup>5</sup> Academic content standards refer to all of Oregon state academic standards and the Oregon CTE skill sets.

COVID-19 symptoms are as follows: <ul style="list-style-type: none"> <li>• Primary symptoms of concern: cough, fever (temperature of 100.4°F or higher) or chills, shortness of breath, difficulty breathing, or new loss of taste or smell.</li> <li>• Note that muscle pain, headache, sore throat, diarrhea, nausea, vomiting, new nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available <a href="#">from CDC</a>.</li> <li>• In addition to COVID-19 symptoms, students must be excluded from school for signs of other infectious diseases, per existing school policy and protocols. This can be done visually as well as asking students and staff about any new symptoms or close contact with someone with COVID-19. For students, confirmation from a parent/caregiver or guardian can also be appropriate.
