Violations Comments

Violation #48. Ware washing: installed, maintained, & used; test strips

Only dishwashing equipment inside of kitchen was 2 compartment sink. Spray bottles with appropriate sanitizer were present in area, so dishes are sprayed with the sanitizer and dried on rack next to 2 compartment sink to sanitize. 3 compartment sink with wash, rinse, and sanitization steps is the minimum washing/sanitization equipment. A dishwasher that adequately sanitizes would also be adequate.

CODE REFERENCE: 64E-11.003(4). Warewashing facilities must be approved, available, maintained, effective, and used for cleaning and sanitizing food-contact surfaces and equipment. Test strips are available and used to verify the solution is at a concentration necessary to achieve sanitization.

Violation #54. Garbage & refuse disposal

Dumpsters are located on top of grass and dirt. They must be located on top of a smooth, non porous surface like concrete instead.

1 dumpster had a visible hole in the side through which it would leak. This dumpster must be fixed or replaced.

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

General Comments

No other violations observed. No kitchen staff present at time of inspection.
