Minutes

On Monday, July 16, 2018, at 6:30 p.m., the Randolph County Board of Education met for their regular monthly Board of Education meeting in the Central Services Board Room at the 2222-C S. Fayetteville Street Office in Asheboro. Board Members in attendance: Gary Cook (Chairman), Tracy Boyles (Vice Chair), Fred Burgess, Sharon Farlow, and Matthew Lambeth. Superintendent Dr. Stephen Gainey, Leadership Team, and Board Attorney Jill Wilson, also were present at the meeting.

Open Session

Call to Order

Chairman Cook called the meeting to order at 6:30 p.m. and welcomed everyone.

Moment of Silence

A moment of silence was observed.

Pledge of Allegiance

The Pledge of Allegiance was led by the Board of Education.

Comments by Superintendent

Dr. Gainey shared that on 6/18/18 the school system's local budget was approved by the County Commissioners to increase the annual funding by \$452,000 in current expense and fines and forfeitures. As a result of the hard work by our County Commissioners and our Board of Education, the school system's annual current expense funding has been increased by \$1,852,442 in recurring money since the start of the 2013-2014 school year and our capital outlay funding has been increased by a total of \$715,264 in recurring money since the start of the 2013-2014 school year. The Superintendent expressed his personal thanks to each of the county commissioners (Mr. David Allen, Mr. Darrell Frye, Ms. Hope Haywood, Mr. Maxton McDowell, and Mr. Kenny Kidd) for their continued support of our school system. On 6/28/18 and 7/12/18 the Superintendent attended the celebration ceremony at the end of each week of summer camp at Southeastern Randolph Middle School. Special thanks went to the school principal Gail Powers and the camp director Judy Hiatt for their leadership in making this year's camp a success. Dr. Gainey also thanked the local businesses, churches, and community members who donated supplies, food, and money for this year's camp, including the Dart Foundation which awarded the school system a \$5,000 grant for the use toward the camp.

1. Dart Foundation grant award for Southeastern Randolph Middle School Summer Camp
Catherine Berry, Assistant Superintendent, shared that the Randolph County School System had been awarded a grant in the amount of \$5,000.00 from the Dart Foundation on June 26, 2018. The grant funds were used to support the purchase of materials and supplies for summer camp projects at Southeastern Randolph Middle School. These materials provided opportunities for students to accelerate their passion for knowledge in Science, Technology, Engineering, and Math (STEM). Ms. Berry expressed her thanks to Nancy Cross, Director for Career & Technical Education/Innovative Design, for pursuing this opportunity. Dr. Gainey expressed his thanks and appreciation to the Dart Foundation for being very supportive of our school system.
