Municipal Building Committee

Dean Petrucelli of Silver Petrucelli & Associates presented a Roof Report showing damage done by age and the microburst. His firm won the bid to do the entire project. The firm did the addition to the Senior Center; the committee was impressed with the details of the presentation and the estimate was more comprehensive.

Option 1 - Shingle Roof

Construction Costs \$3,539,841

State Share (46.7%) \$1,630,805 New Milford Share \$1,909,036

Option 2 - Standing Seam Roof

Construction Costs \$4,226,710

State Share (46.7%) \$1,947,245 New Milford Share \$2,279,465

There is an option to compare the two options, but the committee seemed to be favoring Option 2 as it will be a 40-year roof. The difference is approximately \$370,000. Doing the roof in sections also was discussed. The town has \$1.1 million already set aside to start the project in the areas where there is the most damage. Funding to complete the project can be spread over several years, which the Committee said was a good option.

The committee will vote at its next meeting on February 20 to determine which option they will move forward with.

After long discussion of construction detail, the conversation turned to financing this project. I suggested the sale of the Lillis Administration building would cover the expense. The town has an offer of \$1.6 million on the table. The committee had not heard of or seen any of the plans developed to move the

Central Office to Sarah Noble. I showed the plan I had, which also included the financials. They asked for plans, which will be provided for the next meeting.

The Mayor said the Lillis Building and John Pettione could be sold but that would go to a town vote.

Solar panels on the roof would save money on the \$800,000 high school electric bill and also would help provide income to put to the cost of the roofing projects. Both options would handle solar panels. Panels on the standing seam roof would require less impact on the roof.

The MBC made a motion to task the Facilities Director to investigate a cleanup of the debris on the roof. Kevin has already started the process.

SNIS oil tanks

There was a diverse discussion. Some suggesting a small tank as a backup to the natural gas which is the primary heating source at the school. Others were interested in a much larger tank. It would act as a backup to the town's emergency cars and trucks....fire. police, EMT, and would put a reserve of fuel on the west side of the river in case the bridge was inaccessible.

Northville roof

This was a priority until the macroburst. The building was built in 1983 and has had problems ever since. The roof needs to be ventilated, like the NMHS. State funding would help finance a study to determine the scope of the project.

Security

Dean Petucelli mentioned that the State will automatically help fund any update on a security system. I mentioned that the district has to update our system due to a system that is outdated and no longer supported by the new system.
