

Stewart County Schools Pre-K Information



Pre-Kindergarten Application and Pre-Registration Instructions

<u>Complete an online application</u> and upload all appropriate documentation using a desktop or laptop computer. **Cell phones are not recommended for completing the application.** Online applications may be found on the school's website (Permission Click)

- 1. If your child's immunizations are not current or were last issued in another state, call to schedule an appointment with your child's health care provider or the <u>Stewart County Health Department</u>. Be sure to call for immunization appointments at least 2-3 weeks in advance to ensure that your child's immunizations are received prior to registration.
- 2. All first time Pre-Kindergarten students are required to have a Certificate of Vision, Hearing, Dental, and Nutritional Screening (Form 3300). You may choose to have your child's health care provider conduct this exam, or the exam may also be completed at the <u>Stewart County Health Department</u>.

Important Pre-K Information Required Documents Prior to enrolling

- Proof of Residency
- Current (within 30 days) utility bill such as GA Power with physical address of residence. Utility service must be in the name of the registering parent or that person's spouse. Cell phone bills or mortgage statements are not accepted.
 Cell phone bills will not be accepted as valid proof of residence.
- Certified copy of student's **original birth certificate or other acceptable evidence of age** as specified in Stewart County Board of Education Policy (The state of Georgia requires that students must be **4 years old** on or before 9/1/2021 to enroll in Prekindergarten for the 2021-22 school year.)
- A copy of the enrolling **student's social security card**. (Parent may elect to sign a form at the time of registration stating the individual does not wish to provide the social security number, pursuant to O.C.G.A. 20-2-150.)
- Completed **Georgia Immunization Form** (shot record)
- (Eye, Ear, Dental & Nutritional) Form 3300
- Permanent custody papers through the court if student lives with anyone other than the natural parents. Any court orders that prevent or limit access of a parent to the child or the child's educational records.
- Any restraining orders or other legal documents specifically limiting the access of any individual to the student(s) being enrolled.
- **Picture ID** of parent or legal guardian registering child.
