- 2. Congratulations to Peter Butera and Bella Scappaticci, who qualified for the National History Bee and to our Freshman Bowl team of Bella Scappaticci, Mary Kate O'Brien, Michael DeSanto, Sarah McCormick and Tierney Porfirio who qualified for Nationals in the Junior Varsity Team/Bowl division.
- 3. The Mobile Ag Ed Science Lab has been scheduled to visit the Primary Center in March. The Lab presents specialized classes about agriculture science for the benefit of elementary and middle school students throughout Pennsylvania based on a unique curriculum taught by certified teachers in a mobile agricultural education science laboratory.


