a. Interim Superintendent - Mrs. Melanie Dewakuku

State assessments is still on hold to do executive order shelter in place of the Navajo Nation on extension until March 15. Reauthorization binder is still being worked on. Lunch program is open from 7 am to 1 pm. There will be no meals provided next week due to Spring Break (no school). Regular School Board Meeting was on Friday March 05, 2021, all certified staff/teachers' contracts for next school year was

approved. Planning meetings are on going for next school year, hybrid learning will begin next school year. Not all students will be attending school, will slowly transition all students back into school. There will mostly be A schedule and B schedule. For this school year, virtual learning for the remainder of the year, last day of school will be 06/18/2021. There will be parent forums before school starts next school year. 36 out of 120 staff have reported to have gotten their Covid 19 vaccine. Currently, vaccine is not required for staff. ADE and DODE has not made it mandatory for teachers to be vaccinated.

b. K8 Interim Elementary Principal - Mrs. Marlita Haviland

Ms. EThinn is contacting parents for students to come to the school to take the state assessments. There will be a waiver should a parent not want their child(ren) to come to the school to take the assessment. Attended a meeting with Navajo Nation President, no longer in the red level, announced that Navajo Nation is in the orange level. There will be a Town Hall Meeting on Navajo Nation Presidents Facebook tomorrow. Parent Teacher Conference is this week (March 8th to 12th), contact teachers to schedule an appointment. State assessments will be taken at the High School. These assessments are the important ones, the results are the one that need to be reported and will need to be attached with the reauthorization for the school.
