Dear Parent/Guardian:

As we prepare for the 2019-2020 school year, which begins **August 6, 2019**, we want to remind you of items you may need to present to your child's school

- 1) if you have moved to a new address OR
- 2) if your child will be attending a different school than he/she attended during the 2018-2019 year
 - Current lease, mortgage statement, deed, property tax statement, housing contract
 - Current utility bill associated with that property address (power, water, gas)
 - Legal guardian's ID

3) IF you are in one of the following situations, you must come to MCPSS Student Support Services Division at 1 Magnum Pass, Building A, Mobile, AL 36618 to complete an ENROLLMENT ASSESSMENT FORM (Please see schedule on back):

- Living temporarily with a friend or relative due to loss of housing, eviction, economic hardship, or similar reason
- Living in RV parks OR camping grounds due to lack of adequate alternative accommodations
- Living in emergency or transitional shelters
- Living in a public or private place not designed for humans to live
- Living in vehicles, parks, abandoned buildings, bus or train stations, etc.
- Migratory children living in above circumstances
- Unaccompanied Youth child or youth **NOT** in the physical custody of parent/guardian
- Parent/Guardian is recently deceased or incarcerated
- Parent/Guardian is on military deployment and another person has to enroll child
- Student is placed by DHR. Court or agency with someone other than legal parent/guardian

<u>IF</u> one of these circumstances applies to you, please bring the following to MCPSS Student Support Services:

- The person you are residing with **OR** the contact information for that person
- Your ID and the ID of the person you are living with (person who owns/rents the property)
- 2 proofs of residence from the person(s) you are living with: one proof <u>MUST</u> be a current Lease, Mortgage Statement, Deed, Property Tax Statement, or Housing Contract and the second proof <u>MUST</u> be a current utility bill (power, water, gas) associated with the property address
- Any official mail/bills coming to that residence/address in parent/guardian name

If you are living in a motel/hotel and/or pay-by-the-week establishment and have a **current rent receipt with the name of the establishment**, you may take that **directly** to your child's school as a proof of residence without having to come to Student Support Services.
