Mrs. Downer presented the Superintendent's report—highlighted on the cafeteria odor due to severe weather causing freezer outage (Mr. Johnson suggested using air scrubbers for vents); Title I—Mrs. Swain commented on months being closed out; Special Education—no report (Ms. Ellis still doing good in the dept.); CTAE—Dr. Ingram commented on TKES/LKES as well as ConApp being approved.
