



## AGREEMENT AND RELEASE FROM LIABILITY

### Voluntary Participation

The Consortium for Global Education (CGE) is providing assistance in arranging the Activity, which involves travel to, and voluntary study or teaching in, a foreign country or foreign countries.

### Cancellation

**I agree to notify representative(s) of CGE of any choice to cancel my participation prior to or during the Activity. I will submit this decision in writing. I understand that cancellation will not release me from the legal or moral responsibility to reimburse expenses such as (but not limited to) airline tickets, insurance policies, fees, etc. I promise to repay individuals and/or the above organizations who have incurred such expenses on my behalf.**

### Assumption of Risk

I am aware that the Activity poses risks including but not limited to: sickness, crime, political instability, governmental opposition to project activities, as well as similar and dissimilar risks.

**I AM AWARE THAT THE ACTIVITY IS A POTENTIALLY HAZARDOUS ACTIVITY. I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGERS INVOLVED. I HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH THAT MAY RESULT FROM MY PARTICIPATION IN THE ACTIVITY.**

### Release from Liability

As consideration for being permitted by CGE to participate in the Activity, as consideration for the Consortium for Global Education assisting in arranging the Activity, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby irrevocably and unconditionally release, waive, discharge and covenant not to sue or attach the property of the Consortium for Global Education, or any of their affiliates, subsidiaries, divisions, members, directors, officers, employees and agents (collectively referred to as the “Releasees”), for and from all claims of any nature now or hereafter existing whether known or unknown, including but not limited to all liability, on account of death, injury, or damage resulting from the negligence or other acts, however caused, of the Releasees as a result of my participation in the Activity. **I UNDERSTAND THAT I AM GIVING UP MY LEGAL RIGHTS AND THE RIGHTS OF MY REPRESENTATIVES TO RECOVER FOR INJURY, DEATH, OR PROPERTY DAMAGE.**
