Please be sure to write your child's name on everything (permanent black marker).
The teacher or instructional assistant will walk your child to the car.
As we are getting to know your child, please remain on the campus during your child's
assessment.

COVID-19 Protocols

As a reminder, if one child has a temperature in the car, all students in the car will need to go home for self-monitoring and be cleared by a doctor.
