

WEBSTER COUNTY BOARD OF EDUCATION  
REGULAR MEETING MINUTES  
APRIL 21, 2014 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on April 21, 2014 at 6:00 p.m. Mrs. Linda Rogers, Mr. Donald Brown, Dr. Sophronia Thompkins, Ms. LaToya Riggins, and Mrs. Janie S. Downer, Supt. were present. Mr. Nehemiah Stevens was absent.
