

WEBSTER COUNTY BOARD OF EDUCATION
REGULAR MEETING MINUTES
JULY 11, 2016 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on July 11, 2016 at 6:00 p.m. Mrs. Linda Rogers, Mr. Donald Brown, Mr. Nehemiah Stevens, Mrs. Mary Hinman, and Mrs. Janie S. Downer, Superintendent were present. Mr. Tim Matthews was absent.

Mrs. Linda Rogers called the meeting to order.

Mrs. Linda Rogers gave the invocation.

Mrs. Linda Rogers recognized visitors. No comments given.

The Board approved the tentative agenda by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved 3-1, with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown voting for the motion; Mr. Nehemiah Stevens opposed. The Board approved the June 15, 2016 special called meeting minutes by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved 3-1, with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown voting for the motion; Mr. Nehemiah Stevens abstained. (Unable to carry-out the business matters at the June 13, 2016 regular meeting.)

The Board approved the school handbooks for 2016-2017 (Faculty & Staff, PreK-3 Parent/Student, 4-8 Parent/Student, 9-12 Parent/Student, Alternative School) by a motion made

by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.

The Board approved courses without textbooks for 2016-2017 by a motion made by Mrs. Mary Hinman, seconded by Mr. Donald Brown. The motion was approved unanimously.

The Board approved the school fundraisers for 2016-2017 by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved 3-1, with Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown voting for the motion; Mr. Nehemiah Stevens abstained.

Mrs. Downer presented the Superintendent's report, Title I report and Special Education report.

The Board approved to adjourn by a motion made by Mr. Donald Brown, seconded by Mrs. Mary Hinman. The motion was approved unanimously.
