#### 9. Shared Services Agreement Updates

Mrs. Brown noted that the shared services between Bamberg School District Two and Bamberg School District One are going great. Currently, the District is sharing a Food Service Director, Technology Director, Finance Director, and a Technology Coach. The latest to be added was Mrs. Devon Furr and Mr. Ricky Padgett. They are in Denmark approximately two and a half days a week.

#### 10. **SCAGO General Obligation Bond**

Finance Director Devon Furr requested that the administration be authorized the issuance and sale with SCAGO (South Carolina Association of Government Officials) for a Resolution and Obligation Bond. The District has been passing this Bond every year in order to keep the millage at 109. The Bond will not to exceed \$900,000 nor will it affect the District with consolidation because it is a one-year Bond that will be paid off before going into consolidation on July 1, 2022. Trustee Tony Duncan moved and Trustee Gwendolyn Bamberg seconded to authorize the administration to approve the SCAGO General Obligation Bond and Resolution as presented by Ms. Furr. The motion passed 5-0.
