D. Payment

The purchaser agrees to pay for property awarded to him/her in accordance with prices quoted in his/her bid. Payment must be made within 5 working days of notice of award and be prior to delivery of any of the property.

Form of Payment: Acceptable forms of payment include cash, cashier's check, certified check, and money orders. Personal or business checks will not be accepted.
