How can we improve on training that is offered to parents: To help them work with their child at home? To help them to be active partners in LEA and school decision-making?

1. ACS us focusing on the online tools and programs that are available to parents. Many teachers at ACS use some form on online classroom participation. (i.e. Google Classroom, SeeSaw, Remind 101, ClassDojo, etc.) Teachers could spend extra time introducing parents to these online tools either during an Open House or by sending home a pamphlet that explains how to access these tools. We provide a link to all online tools that our teachers and students utilize on the school website. Teachers also give explicit information to parents and students on their LMS that instructs parents and students on how to use the tools.

How can we improve on training that we offer school staff/teachers to help them to work more effectively with parents?

- 1. We have a mentoring program for new teachers to cover the topics of enhancing teacher-parent relationships.
- 2. Teachers fill out a "Positive Phone Calls" sheet every week. These are kept on file at the high school and junior high school. This encourages positive interaction with parents.

- 1. We need to get more training in PowerSchool and the available data that parents can access regarding their child's grades, behavior, and lessons.
- 2. We need to continue to update the school website with relevant information for parents.
