He is excited about the coming collaboration time staff will have and thought we were off to a great start.

She shared about the first two days of school, new staff members, concern over decline in enrollment of 40 at North Cottonwood from last year on this day, back-to-school night is coming on Thursday, YMCA after school program has 111 students participating, Preschool has 20 students already, and they are trying to get the new technology and curriculum set up for new teachers.

Mr. Geren thanked Mrs. Wright for her help on the schedule at West Cottonwood, back to school night went well last night, very positive start, maintenance staff have done a good job getting projects done over the summer months.
